PUBLIC NOTICE

In compliance to the provision contained in section 45, 62 & 64 of The Electricity Act'2003 and CSERC (Terms and conditions for determination of tariff according to Multiyear Tariff principles and methodology and procedure for determination of Expected revenue from tariff and charges) Regulation'2015, Chhattisgarh State Power Distribution Company Ltd. has filed MYT Petition comprising of Provisional true up for 2014-15, Multiyear Tariff Aggregate Revenue Requirement for each year of control period i.e. FY 16-17 to FY 20-21; Revenue from existing tariffs and charges and projected revenue gap for 2017 & Determination of retail tariff for FY16-17. The petition is registered as petition No. 01/2016(T). The proposed Annual Revenue Requirement of CSPDCL for each year of control period is given in the table below:-

The petition is subject to adjustment of revenue subsidy, if any, extended by the State Government and modifications on account of compliances to the direction of Hon'ble ATE. According to principles of law stipulated in APTEL order dtd. 09.10.2015 in Appeal No. 308/2013 and Provisional true up for 2014-15 a total revenue gap till FY16-17 is Rs.2027.83 crore . This gap along with ARR for FY16-17 is proposed to be recovered by way of appropriate changes in tariff for all categories in FY16-17 in accordance with provisions of National Tariff Policy.

Copies of the Tariff petition in English and gist in Hindi will be available in the offices of CSERC and Executive Director(Commercial) CSPDCL, Dangania Raipur and CSPDCL's Regional /Circle Offices of O&M at Raipur, Bilaspur, Durg, Jagdalpur, Rajnandgaon and Ambikapur, which can be purchased on any working days on payment of Rs.500/- for tariff petition and Rs.50/- for gist in Hindi. Copy of the petition may be obtained by post on payment of additional charges of Rs.50/-.

Persons intending to file objection/suggestion/views relating to this petition may file with copies of documents and supporting evidences thereof directly to Executive Director (Commercial), 4th Floor, Sewa Bhavan, CSPDCL, Raipur and / or Secretary, CSERC, Irrigation Colony, Raipur, within 21 days from the publication of this Public Notice in newspapers.
