Ref:- i) Chhattisgarh State Electricity Regulatory Commission's tariff order dated 17.04.2017 under petition no. 64 of 2016(T)

Chhattisgarh State Electricity Regulatory Commission vide tariff order dated 17.04.2017 under petition no. 64 of 2016(T), effective from 01.04.2017, has given directive regarding VCA charges that :

VCA Charges for the period December 2016 to March 2017 shall not be billed to retail consumers.

Variable cost Adjustment (VCA) Charge on consumption from April 1, 2017 as per the formula and conditions specified in the MYT Regulations, 2015 shall be levied in addition to energy charge on all the LV and HV categories including temporary supply.

On approval of competent authority, this office letter no. 3833 dt 17.03.2017 regarding levy of VCA charges for 5th bi monthly period of 2016-17 i.e. 01.12.16 to 31.01.2017 is hereby withdrawn w.e.f. the date of applicability of new tariff i.e. from 01.04.2017.

It is therefore requested to kindly arrange to make suitable programme in SAP to stop recovery of VCA charges for the period December '16 to January'17 from the date of applicability of new tariff i.e. 01.04.2017.
